Abstract: Implementation of Angelic Responsibility Traits in Teachers' Duties in the Modern Era: An Islamic Education Perspective

Objective: This study examines the implementation of angelic responsibility for teachers' duties in the modern era from an Islamic educational perspective. **Method:** This study uses a qualitative approach with hermeneutic analysis based on the Part and Whole theory to understand the role of teachers in teaching knowledge and educating students' character through Islamic teachings, with religious texts as the primary data source. **Results:** The study shows that the angelic sense of responsibility can enhance the quality of teaching and students' morality and foster an integrity-driven generation. Teachers in the digital age also face challenges in upholding Islamic values amid societal developments. **Conclusion:** Implementing the angelic trait of responsibility in teacher education in the modern era can serve as a guideline for improving the quality of education and student morality. This trait of responsibility develops academic competencies and students' character according to Islamic teachings. **Contribution:** This study makes an important contribution to the development of Islamic education curricula, particularly in introducing character values based on Islamic teachings as a foundation for teachers in performing their duties.

Abstrak: Implementasi Sifat Tanggung Jawab Malaikat Terhadap Tugas Guru di Era Modern: Perspektif Pendidikan Islam

Objektif: Penelitian ini bertujuan untuk mengkaji implementasi sifat tanggung jawab malaikat terhadap tugas guru di era modern, dalam perspektif pendidikan Islam. **Metode:** Penelitian ini menggunakan pendekatan kualitatif dengan analisis hermeneutik berbasis teori Part and Whole untuk memahami peran guru dalam mengajarkan ilmu dan mendidik karakter siswa sesuai ajaran Islam, dengan teks-teks keagamaan sebagai sumber data utama. **Hasil:** Penelitian menunjukkan bahwa sifat tanggung jawab malaikat dapat meningkatkan kualitas pengajaran, moralitas siswa, dan membentuk generasi berintegritas. Guru di era digital juga menghadapi tantangan dalam mempertahankan nilai-nilai islami di tengah perkembangan zaman. **Kesimpulan:** Implementasi sifat tanggung jawab malaikat dalam pendidikan guru di era modern dapat menjadi pedoman dalam meningkatkan kualitas pendidikan dan moralitas siswa. A. INTRODUCTION

Belief in angels is one of the pillars of faith in Islam, which teaches the importance of believing in the existence and duties of angels as assigned by Allah SWT ([Lubis, 2016](#)). Angels are known as beings who always obey His commands without deviating from their entrusted tasks ([Hasan, 2018](#)). In education, the exemplary nature of angels can serve as a model for teachers in fulfilling their responsibilities, particularly in shaping students' character ([Amelia, 2021](#)).

A teacher's responsibility, like the duties of angels, should ideally be carried out with complete sincerity and obedience without deviating from the noble goal of guiding the younger generation onto the right path ([Uno & Lamatenggo, 2016](#)). The Angelic Attribute of responsibility toward teachers' duties in the modern era from an Islamic education perspective emphasizes the importance of integrating spiritual and professional aspects in education. In this context, the nature of angelic responsibility, which includes honesty, patience, and devotion to Allah, can be a model for teachers facing the challenges of educating the younger generation in the digital age. The emphasis on character and moral education in the Islamic perspective fosters academic quality and shapes individuals who are virtuous and responsible in their social lives. Teaching these values to students, especially amid rapid technological advances, is key to creating a generation that is intellectually intelligent and strong in integrity and spirituality.

In this modern era, the roles and responsibilities of teachers are beginning to shift ([Fibrianto & Yuniar, 2020](#)). The rapid development of technology and easy access to information have changed how students acquire knowledge and shape their thinking patterns ([Handulusih et al., 2024](#)). Currently, students no longer rely solely on teachers as their primary source of knowledge but instead utilize digital technology and various online learning resources ([Sundari, 2024](#)). Although this progress has brought benefits to the development of education, at the same time, the responsibility of teachers to accompany and guide students has diminished ([Rohartati, 2022](#)). Many teachers focus more on fulfilling administrative demands and curriculum targets, thereby neglecting personal interaction, which should primarily shape students' character and moral values ([Nabila et al., 2024](#)).

This phenomenon raises issues that need to be addressed, namely the tendency for the intensity of the relationship between teachers and students to decline and the decreasing role of teachers in instilling values of goodness that align with the principle of faith in angels. Just as angels bear a great responsibility to carry out their duties with sincerity and obedience, teachers should also emulate this attitude in carrying out their responsibilities as educators and as moral and spiritual guides for students.

Therefore, this research is crucial for exploring how the values associated with faith in angels, particularly their sense of responsibility, can be integrated into educational practices in a more holistic and impactful way in the modern era. The core values of angels, such as discipline, commitment, and sincerity, offer a rich source of inspiration for educators seeking to embody these qualities in their teaching approach. By understanding and emulating these angelic traits in executing their duties, teachers can restore and reinforce their primary role not only as conveyors of knowledge but also as moral guides who instil values of goodness, integrity, and social responsibility in the students they mentor. This approach aims to create an educational environment where academic excellence and moral character development go hand in hand, shaping future generations that are intellectually competent, ethically responsible, and spiritually aware. Furthermore, this research highlights the need for a broader understanding of how spiritual and moral dimensions, grounded in religious teachings, can complement traditional educational goals, fostering a more balanced and compassionate society.

Although many studies have discussed the role of teachers in Islamic education, there is still a lack of research on the application of angelic traits as guidelines for teachers in the

modern era. Angelic traits such as loyalty, obedience, and patience are often not discussed in depth in the context of how these traits can be applied in facing contemporary educational challenges. Therefore, this study aims to examine and analyze the implementation of angelic responsibility in the duties of teachers in the modern era, focusing on applying these values in improving the quality of Islamic education, both in terms of academic results and character building of students.

B. METHOD

This study uses Gadamerian hermeneutic analysis, which aims to deeply examine the implementation of angelic responsibility in the duties of Islamic Religious Education (IRE) teachers in the modern era. The research design is qualitative and uses a Gadamerian hermeneutic approach. The primary focus is to understand the meaning contained in relevant texts about the nature of angelic responsibility and how this nature can be applied to the duties of PAI teachers in the modern era. This research adopts an interpretive perspective that allows researchers to understand and explore the relationship between moral and ethical theories in Islam and educational practices.

This research was conducted in 2024. The object of this research is the implementation of the nature of angelic responsibility in the duties of PAI teachers. The primary focus is to examine how characteristics such as loyalty, obedience, and devotion of angels can be adapted and applied to the duties of PAI teachers in Islamic schools in the modern era. The researcher will analyze various literature, scientific articles, and reference sources that discuss Islamic religious education and moral values in education.

Data in this study was collected through a literature review approach by examining various relevant literature, such as scientific articles, textbooks, and other reference sources that discuss the nature of angelic responsibility in Islamic teachings and the role of teachers in religious education. The data collection process was carried out by searching for and selecting reading materials that contained information related to the nature of angels, educational ethics, and Islamic educational practices.

Data analysis was conducted using Gadamerian hermeneutic analysis techniques, which included the following stages: (1) the initial understanding stage (prejudices); (2) the text interpretation stage; (3) the reflection and dialectic stage; (4) the synthesis and conclusion stage.

By using Gadamerian hermeneutic analysis, this study is expected to provide deeper insights into how the values of angelic responsibility can be a source of inspiration for PAI teachers in carrying out their duties, as well as their relevance in the context of Islamic education in the modern era, which increasingly demands professionalism and high dedication.

C. RESULTS AND DISCUSSION

Result

The focus of this study includes the interpretation of books on the nature of angelic responsibility, which are then analyzed in terms of parts and wholes. In hermeneutical studies that use the Part and Whole approach, the analysis focuses on the relationship between the parts in the table (namely, the nature of angelic responsibility, the duties of teachers, and the Islamic education model) and the overall context of the books used as references. The results of the analysis are presented in the following table:

1. Sections (Part)

The parts in this table are specific elements, namely the nature of angelic responsibility, the duties of teachers, and the Islamic education model associated with each book mentioned. In this case, each aspect of angelic responsibility in these books can be interpreted as a specific component or aspect that leads to a broader understanding of the responsibilities of teachers in Islamic education.

- The characteristics of angelic responsibility, such as loyalty, obedience, diligence, patience, and devotion, are ethical and moral values in Islamic teachings about angels and how they carry out their duties.
- The Teacher's Duties in the table reflect how each of these angelic traits is relevant to the role of teachers in education. For example, teachers who are loyal in educating students, are patient in facing challenges in the classroom or are obedient to religious teachings as examples for students.
- The Islamic Education Model listed in the table refers to a holistic approach that integrates the moral values taught by the characteristics of angels into educational life. For example, teaching prioritizes obedience to Allah, loyalty in carrying out duties, or patience in educating students.

2. Overall (Whole)

This overall analysis refers to the big picture of how the nature of angelic responsibility taught in these books shapes a larger concept of the role of teachers in Islamic education and the overall model of Islamic education. This approach leads to the understanding that the task of teachers is not limited to imparting knowledge but also involves shaping students' characters by Islamic teachings.

- a) The books provide an understanding that the teacher's task is more than just a profession; it is a calling to be a guardian of trust who has a character by the attributes of angels, which include loyalty, obedience, patience, and devotion. Thus, teachers are considered to be the executors of the tasks of angels in a more human context.

3. The Relationship between Parts and the Whole

- a) Part: Each book discusses the nature of angels separately but significantly influences the teacher's duties in the context of education. For example, a book that discusses the patience of angels will link this value to the teacher's duty to be patient in facing challenges in the classroom.
- b) Whole: Overall, the angelic traits described in these books form a comprehensive model of Islamic education. Islamic education is about academic knowledge and moral and spiritual teaching, leading to student character formation through Islamic values.

Discussion

1. Belief in Angels

Belief in angels is one of the most important pillars of faith in Islam, emphasizing the believers' conviction in the existence of Allah's invisible creatures (Rahmi, 2016). Angels are believed to be invisible beings who actively carry out Allah's commands and rules in the universe. They serve as symbols of obedience and as intermediaries between Allah and humanity in matters related to life, death, and the Day of Judgment (Rohmah, 2019). Understanding the concept of faith in angels is not only a belief in invisible beings but also reinforces the understanding that there is a profound divine mechanism in Islam, where Allah regulates everything with a structure and order full of wisdom.

The Qur'an is the primary source that teaches Muslims to believe in angels as part of their faith in Allah. In Surah Al-Baqarah verse 285, Allah SWT states that believing in angels is part of the fundamental faith (Qatrunnada & Solianti, 2024). This verse indicates that angels are Allah's special creations and are important in religion. Angels are not only present for the sake of creation but also play a direct role in the daily lives of Muslims (Juniarti, 2024). They are creatures created with absolute obedience to Allah and never disobey or commit sins, as stated in Surah An-Nahl, verses 49-50 (Shihab, 2020). These verses explain that all creatures in the heavens and on earth prostrate themselves before Allah, including the angels who always carry out what is commanded.

In addition to the Qur'an, the hadith provides significant explanations about angels. In a hadith narrated by Umar bin Khattab, the Prophet Muhammad explained that belief in angels is one of the six pillars that form a person's faith (Anugrah et al., 2019). This hadith explains that belief in angels is not merely a matter of trusting in unseen beings but also understanding their roles and responsibilities in human affairs. The existence of the angels Raqib and Atid, who record every human action, for example, reminds Muslims that every deed will be judged and remembered, whether good or bad (Prihatini, 2020). Angels do not possess free will like humans; they are always obedient and submissive to Allah, and this serves as an example for Muslims in their daily lives.

Angels possess several unique characteristics that distinguish them from other creatures. One such characteristic is that angels are invisible beings that ordinary humans cannot see, except under exceptional circumstances, such as when the angel Jibril appeared to the Prophet

Muhammad in human form ([Aini et al., 2024](#)). They are also created from light, as mentioned in a hadith narrated by Aisha RA, where the Prophet Muhammad SAW explained that angels are created from light, unlike humans, who are created from clay and jinn, who are created from fire ([Ridha, 2014](#)). Angels also have no biological needs, such as eating, drinking, or sleeping, as they are constantly worshipping and carrying out Allah's commands without ceasing ([Abdullah, 2018](#)). These unique characteristics reinforce angels' position as special beings completely dedicated to obedience to Allah.

Each angel has a specific task Allah assign ([Maryanto et al., 2014](#)). The angel Jibril, for example, is the bearer of revelation tasked with conveying the word of Allah to prophets and messengers, including the Qur'an, to the Prophet Muhammad. Mikail, another angel, is tasked with regulating sustenance and blessings in the universe so that Muslims are taught to be grateful and trust in Allah in seeking sustenance because they believe that Allah, through His angels, has regulated all their needs in life. Izrail is tasked with taking lives, reminding humans that life in this world is temporary and that they will return to the Creator. The angel Israfil will blow the trumpet on the Day of Judgment as a sign of the end of life and the beginning of the afterlife. Additionally, the angels Raqib and Atid record every human action, and Munkar and Nakir test humans in the grave ([Rohmah, 2019](#)).

Belief in these angels motivates Muslims to obey and maintain good deeds ([Rhamdani et al., 2023](#)). The awareness that all deeds will be recorded and accounted for before Allah motivates us to always act according to religious teachings. The belief in the existence of angels who never disobey Allah's commands also serves as an important example for Muslims always to perform good deeds with sincerity ([Rivan et al., 2023](#)). In addition, faith in angels teaches Muslims to understand and accept destiny, where Allah has arranged everything in this world through His creatures.

Faith in angels is one of the main foundations that strengthens Muslims' faith and their spiritual relationship with Allah. Through this faith, Muslims understand that Allah created and governs the universe with wisdom and that a divine system always watches over and governs life. Belief in angels always motivates us to obey Allah, increase awareness of responsibility for all actions, and build better character in daily life.

2. The Concept of Responsibility in Angels in Islam

The responsibility of angels in Islam is related to the performance of their duties and the noble qualities that reflect obedience, trustworthiness, and patience in carrying out Allah's commands ([Maryanto et al., 2014](#)). Angels are creatures created to perform various tasks crucial for the universe's functioning, ranging from conveying revelation to prophets, recording human deeds, and maintaining the universe's harmonious system ([Shihab, 2020](#)). Every task they undertake is carried out with complete discipline, without doubt, or uncertainty ([Alam & Andika, 2020](#)). Their responsibilities reflect Islam's ideal concept of responsibility: trustworthiness, obedience, sincerity, justice, and patience.

One of the main aspects of the angels' responsibility is trustworthiness ([Fauzi & Hamidah, 2021](#)). Angels always carry out the tasks Allah gives them wholeheartedly and without negligence. They never neglect the tasks given to them, even in cases that seem very difficult. For example, the angels tasked with recording human deeds never neglect or misrecord them, even though this task is important for humanity's accountability in the afterlife. Thus, angels symbolize honesty and integrity in fulfilling every obligation ([Rhamdani et al., 2023](#)).

Additionally, angels demonstrate unconditional obedience to Allah ([Kahar, 2018](#)). They never question the commands given to them, even though these tasks are often vast and complex. The angel Jibril, for example, as the bearer of revelation to the prophets, constantly carries out Allah's commands to convey revelation with great precision without doubting or delaying the task entrusted to him. This perfect obedience teaches us always to obey Allah without reason or personal motive, and to carry out every command of His with all our heart and mind ([Hakim, 2021](#)).

Sincerity is also an important value in the responsibility of angels (Yugo & Surana, 2024). Angels carry out all their duties solely to serve Allah without expecting praise or rewards from other creatures. They never desire recognition, even though their tasks are cumbersome and risky. Responsibility carried out with sincerity is an example for humanity, who should carry out their duties selflessly, solely for Allah's sake and for humanity's good (Ngadhimah & Susirah, 2017).

Angels also show that responsibilities must be carried out fairly (Abdullah, 2018). Angels tasked with recording human deeds, such as the angels Raqib and Atid, always write fairly and without discrimination. They record every deed accurately and honestly, regardless of a person's social status, wealth, or position. Responsibility carried out with fairness reflects the value of justice highly upheld in Islamic teachings. As Muslims, we are taught to carry out our duties reasonably, without favouring or discriminating against anyone, and to act reasonably in every aspect of life (Rangkuti, 2017).

The responsibilities carried out by angels are also fulfilled with extraordinary patience (Maryanto et al., 2014). They never complain, even though their tasks are cumbersome and often take a long time. For example, the angel Izrail, who is tasked with taking the life of every living creature, carries out this duty with patience, as it is a command from Allah that must be carried out without delay. The patience angels possess serves as an example for humanity in facing various trials and challenges in life. Just as angels do not feel burdened by their heavy tasks, Muslims are taught to face life's difficulties with patience and not easily give up (Rashid, 2015).

Angels in Islam symbolize the ideal sense of responsibility, which must be carried out with trustworthiness, obedience, sincerity, justice, and patience. Every aspect of these angelic qualities teaches humanity to fulfil its duties and obligations with the highest integrity. As humans who are also given responsibilities in this world, we should emulate the noble qualities of angels in our daily lives, whether in family, work, education, or service to society. By emulating these qualities, we can live a more meaningful life full of responsibility and in harmony with Allah's commands.

3. The Implementation of Angelic Responsibility in the Role of Teachers in the Modern Era

The implementation of angelic responsibility in the role of teachers in the modern era has a positive impact on the quality of teaching. It plays a crucial role in shaping students' character. In Islam, angels are known for their noble qualities, such as trustworthiness, obedience, sincerity, justice, and patience in carrying out their duties. These qualities are highly relevant to teachers, who must perform their duties with full responsibility, especially in facing the challenges of education in this increasingly developing era. Amid technological advancements and globalization, teachers are expected to teach effectively and be role models in students' daily lives.

a. Trustworthiness in performing duties

The trustworthiness angels in Islam demonstrate honesty, integrity, and punctuality can serve as a highly relevant example for teachers in the modern era. Angels are creatures created by Allah with specific tasks, and angels never falter or hesitate in carrying out these tasks. They consistently execute Allah's commands with perfect precision and attention to detail. This reflects a high level of trustworthiness related to the tasks assigned and the commitment to fulfilling obligations with complete sincerity.

Similarly, in the teaching profession, especially in the modern era filled with challenges and rapid changes (Saerang et al., 2023), teachers have a noble and important duty: to educate and guide the next generation. This task concerns teaching lessons and imparting life values that shape students' character (Adha & Ulpa, 2021). In fulfilling this duty, teachers must possess a high sense of trustworthiness as they serve as educators and role models for their students.

A trustworthy teacher carries out their teaching duties responsibly, honestly, and diligently (Mutaqin et al., 2021). Like an angel who never fails in their duties, a trustworthy teacher will always ensure that every lesson delivered is accurate in content and presented in a way that is appropriate and acceptable to students. A trustworthy teacher will not waste class time and will always ensure that every opportunity in the classroom is used for maximum learning. They will arrive on time, prepare materials well, and give full attention to students so that the teaching and learning process runs effectively (Erwinskyah, 2017).

The responsibilities of teachers in the modern era are also becoming increasingly complex. In addition to teaching, teachers must be able to adapt to technological developments, face social challenges, and understand the increasingly diverse needs of students (Budiana, 2021). Teachers not only play the role of educators but also as mentors, motivators, and facilitators who guide students in their character development and emotional intelligence. In this context, trustworthiness means imparting knowledge and educating students to become responsible, honest, and integrity-driven individuals character traits they can emulate from the trustworthy behaviour demonstrated by their teachers.

Just as angels always carry out their duties fairly, a trustworthy teacher must also assess and evaluate student progress fairly. In education, assessment is one of the most important forms of responsibility (Darmadi, 2015). A trustworthy teacher will not give unfair or unrealistic assessments. They will provide objective and constructive evaluations that help students understand their strengths and weaknesses and allow them to improve. An honest and fair assessment is a form of a teacher's integrity in fulfilling their responsibility toward quality education.

Additionally, integrity is reflected in teachers' efforts to develop themselves continuously. In the modern era, the advancement of science and technology moves very quickly. Trustworthy teachers will always strive to update their knowledge and skills to provide the best teaching (Mursalin, 2022). They will not stop learning, even if they already hold a degree or have extensive teaching experience. Like angels who always carry out their duties perfectly without fatigue or doubt, trustworthy teachers will continue to learn and develop to fulfil their responsibility to provide quality education for students.

Teachers need to instil this sense of responsibility in their students. A teacher's responsibility extends beyond the knowledge they impart but also encompasses the character development of their students. A responsible teacher will instil the importance of integrity, honesty, and punctuality in their students (Buan, 2020). They will teach these values in everyday life, both inside and outside the classroom. Through good examples and responsible teaching, teachers help students grow into individuals who can take responsibility, just as angels always carry out their duties with trustworthiness.

b. Unconditional obedience

F. CONCLUSION
